<u>Ingestion</u>	If swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.
<u>Skin Contact</u>	Flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.
